\*The Firm is the investment manager to Melvin Master, Melvin Capital Onshore LP, a Delaware limited partnership ("Melvin Onshore"), Melvin Capital II Ltd, a Cayman Islands exempted company ("Melvin Master II"), and one or more managed accounts (the "Managed Accounts" and together with Melvin Master, Melvin Capital II and Melvin Onshore, the "Melvin Funds and Accounts"). As of April 16, 2020, the Firm may be deemed to beneficially own an aggregate of 11,959,075 shares of Common Stock of the Issuer consisting of (i) 4,823,299 shares of Common Stock and call options to purchase up to 2,079,300 shares of Common Stock held by Melvin Master, (ii) 565,893 shares of Common Stock and call options to purchase up to 242,400 shares of Common Stock held by Melvin Onshore, (iii) 1,561,409 shares of Common Stock and call options to purchase up to 683,200 shares of Common Stock held by Melvin Master II and (iv) 1,398,474 shares of Common Stock and call options to purchase up to 605,100 shares of Common Stock held by the Managed Accounts.
